- 2) Use light, consistent pressure; let the diamond do the cutting.
- 3) Move the grinder in slow, overlapping passes to maintain uniformity. Avoid holding the tool in one spot to prevent gouging soft concrete.
- 4) Check scratch patterns frequently. If the surface appears too rough, reduce pressure or make additional light passes.
