- 2) Apply light, even pressure; let the resin pad do the work
- 3) Move in slow, overlapping passes across the surface
- 4) For edges and corners, work carefully for consistent finish
- 5) Keep the pad moving to prevent hot spots or uneven gloss
- 6) Check for consistent scratch patterns and uniform surface smoothness and ensure minor scratches from coarser pads are removed before moving to finer pads
